From the President

It looks to be the best of summers on Lake Erie as many are enjoying a very busy time across the lakeshore. Hopefully, we will also realize an increase in the number of people who want to learn about Lake Erie's challenges and with us, become inspired to be part of our ongoing efforts to protect this incredible natural resource!

It was a pleasure for Lake Erie Foundation to participate in the Progressive Cleveland Boat Show and Catawba Island Club boat show. Our appreciation to Lake Erie Marine Trade Association for working so diligently to host these events. At the Catawba Island Boat show upwards of 6,000 people attended the show which was held April 29 - May 1. Dozens of boat dealers filled dock slips while a full complement of marine vendors lined the marina perimeter for three days of celebrating being able to gather together again to share the love of boating and Lake Erie.

Lake Erie Foundation (LEF) was there with a display focusing on the dangers of microplastic contamination in the lake. We received several new members and business sponsors from these interactions and some strategic partnerships with other organizations were also formed.

LEF has selected plastic pollution in the lake as a major focus area for 2022. Several recent articles about the dangers it can pose along with an informational video and tips on how you can help have been posted to our website. Visit LakeErieFoundation.org and select "Plastic Contamination" from the list of challenges under the "Lake Erie Issues menu.

This focus on plastic does not mean that LEF will reduce our attention regarding the challenges that algal blooms bring to the lake. We continue to support the H2Ohio programs of the DeWine Administration and advocate for the additional work and collaboration we feel is necessary to adequately address the problem.

NOAA will be releasing its early projection for the anticipated severity of this year's algal bloom in mid-

June. Lake Erie Foundation will send an email blast with the projections once they

- are released. We know that we must not let up on our efforts to affect the changes in agricultural practices and other actions that will result in a permanent solution. We continue to meet with entities
- that can help us to continue to work for the ultimate goal of a 40% reduction in phosphorus runoff.



We also continue to monitor the Icebreaker project. We're watching the lawsuits that are in the Ohio Supreme Court and the Federal Court in the District of Columbia and will update our supporters when new information is available. There is an overwhelming concern regarding wind turbines in Lake Erie and LEF firmly believes all environmental studies must be completed before the project moves forward.

A very special thank you to our friends and long-time supporters, Clemons Boats in Sandusky, for again designating LEF the charity of choice during their Customer Appreciation event this August. There will be a fun-filled day of boating events followed by a party
